Crime Activity and Prevention:

Captain Fairhurst of the San Jose Police Department gave an overview and update of the recent crime activities in the area, in particular the two shootings that happened on Hamilton Avenue. It was suggested that we arrange a Gang Awareness Training for our community members. Community members are encouraged to call 911 to report any loitering or gang activities; these calls can remain anonymous. San Jose has a 90+% homicide solution rate.
