### **Proceedings:**

Meeting called to order at 7:00 p.m. by Heather Sutton.

### **Crime Activity and Prevention:**

Capt. Finch reported a fairly steady past couple of months considering the summer typically tends to have a seasonal increase in crime. Automobile theft is on the uprise and the community is advised not to leave their vehicles unattended while running and to be cautious of leaving valuables in view.

A \$360K grant has been approved for a signal light at the Hamilton/Phoenix intersection.

Sergeant Drake the SJPD reported four officers have been assigned to a special investigation of groups of gypsies, targeting primarily the elderly by going door to door distracting and stealing. This is not just a local issue it is happening all over the country.

The curfew for children is still 10pm, unless they are in transit, for example on the way home from the movies.

A new officer has been assigned the Winchester/Loma Verde area resulting in decreased gang activity. The police have constant meetings with owners/residents in that area.

The two recent homicides investigations are still ongoing.

Motorized scooters need to be licensed and should only be operated by a licensed driver.

**Finance Report:**

Heather Sutton presented the treasurers report. Funds have been spent on the Block Party, Garage Sale Event and Insurance. It was MOTIONED - and APPROVED (Sue Bose Second) to accept the treasurers report. Additional membership forms and donations were accepted.

**CAP Grant:**

Our City of San Jose Grant check for \$14,400 has been received and deposited.

**CBAC (Community Board Advisory Committee):**

We welcomed Erin Mclaughlin as our STWNA representative. Erin will attend CBAC meetings and report back to STWNA on the activities of the board which is comprised of various association, school, business and community members. Sample issues that are discussed in the past CBAC meetings are:

- Community Facility Usage
- Location of the Charter School
- School Gates Being Locked
- Gang Violence
- Budget
- Construction

Although the board has agreed to keep school gates open after school hours, Payne School will remain closed during the construction phase. Once the construction is complete, the school will remain open (hours to be determined), however dogs are strictly prohibited on the school grounds.

Community members reported that Latimer School field is not open.

Bylaws applicable to board vacancies:

**ARTICLE IV****Officers**

- Second Vice President: The Second Vice President shall assist the President by overseeing the function of the meetings and ensuring accordance with Robert’s Rules of Order. Other duties shall be performed as required by the President or Board.
- Section 6 (Vacancies) If an officer resigns or becomes ineligible to hold office, the office shall immediately become vacant. If the office of President is vacant, the First Vice-President, shall immediately

assume the office of President until the expiration of the President's term. For any other vacancy, the Board shall immediately appoint an eligible replacement, with membership approval until the expiration of the term of office.

Due to the growth of our organization it is suggested we expand our board to 7 persons.

We will investigate having a representative from code enforcement present at one of our meetings to advise us on the issue regarding abandoned shopping carts.
